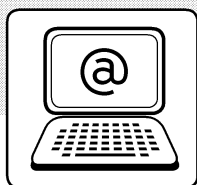


Form of Instruction - Annual General Meeting to be held on 29 April 2021

**To be effective, all forms of instruction must be lodged with the Company's Depositary at:
 Computershare Investor Services PLC, The Pavilions, Bridgwater Road, Bristol BS99 6ZY by 23 April 2021 at 11.00 am.**

Explanatory Notes:

1. Please indicate, by placing "X" in the appropriate space overleaf, how you wish your votes to be cast in respect of each of the Resolutions. If this form is duly signed and returned, but without specific direction as to how you wish your votes to be cast, the form will be rejected.
2. The vote 'Withhold' option overleaf is provided to enable you to abstain on any particular Resolution. However, it should be noted that a vote 'Withheld' is not a vote in law and will not be counted in the calculation of the proportion of the votes 'For' and 'Against' a Resolution.
3. To give an instruction via the CREST system, CREST messages must be received by the issuer's agent (ID number 3RA50) by 23 April at 11.00 am. For this purpose, the time of receipt will be taken to be the time (as determined by the timestamp generated by the CREST system) from which the issuer's agent is able to retrieve the message. The Company may treat as invalid an appointment sent by CREST in the circumstances set out in Regulation 35(5)(a) of the Uncertificated Securities Regulations 2001.
4. Any alterations made in this form should be initialled.
5. In order to prevent the spread of the COVID-19, the AGM will be organised so that shareholders are not to be present at the meeting venue. Votes, questions and counterpro-posals must be submitted in advance of the meeting. Should you wish to attend the meeting via webcast please email your request to !UKALLDITeam2@computershare.co.uk to obtain a letter of representation.
6. Should you require a copy of the Notice of Meeting and Management Information Circular, please contact the Depositary in writing, by email !UKALLDITeam2@computershare.co.uk or alternatively ring 0370 702 0000.
7. Entitlement to attend via webcast and vote at the meeting and the number of votes which may be cast thereat will be determined by reference to the Depositary Interest Register at close of business on 12 March 2021.
