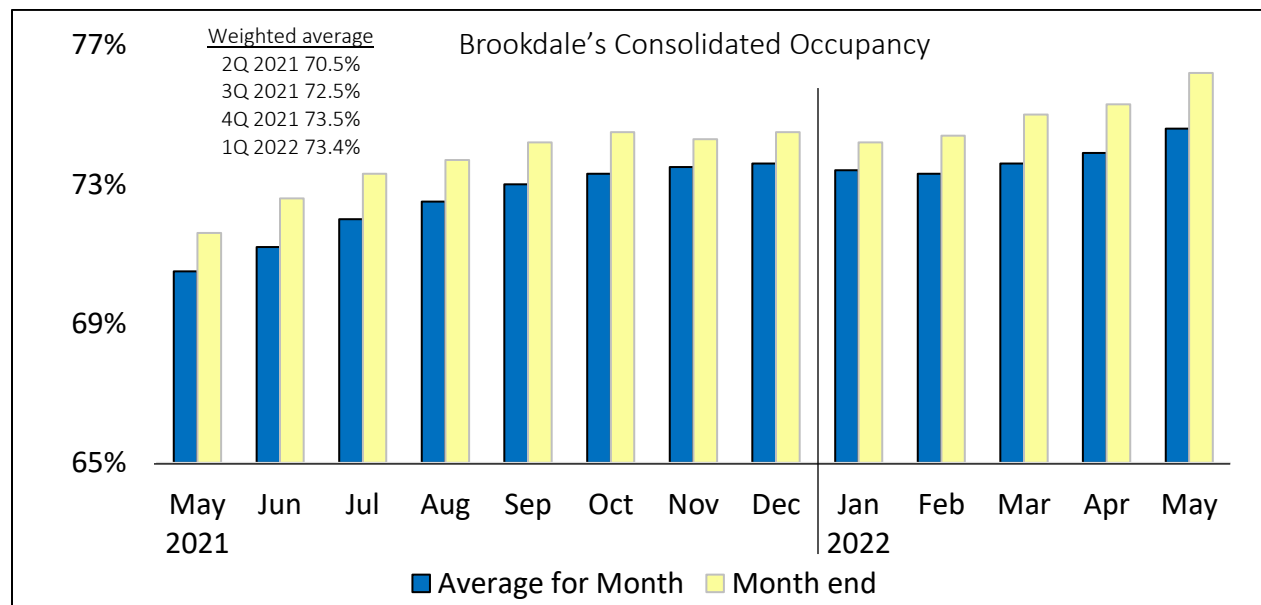




## Brookdale Reports May 2022 Occupancy
